SUBJECT: NOMINATION FORM – UNDERGRADUATE SUPREME COUNCIL MEMBERS

One of the most prestigious honors in our Fraternity is serving as a voting member of the Supreme Council. It is my pleasure to call for nominations of undergraduate members to this position. The Supreme Council members focus on the vision for our Fraternity over the long term and serve as role models in living the values taught by our Ritual. The Fraternity has been fortunate to have many outstanding undergraduates serve in this position who have contributed to the success and strength of our beloved organization.

The attached form will be used by the Supreme Council to appoint two undergraduate Supreme Council members for 2011-2012. The form should be completed by each applicant and sent to the Memorial Headquarters by May 15, 2011. This provides several months for each nominee to complete his application. The deadline will not be extended.

The Supreme Council's decision will be based on qualifications of the applicant and other pertinent factors. The two undergraduate Supreme Council members will be appointed in August 2011 immediately after the conclusion of the 2011 Academy to serve a term of one year. The appointed members should be available to attend four Supreme Council meetings to take place during their term including the 2012 International Convention scheduled for July 26-30, 2012 in Denver, Colorado.

Undergraduate members of the Supreme Council are not expected to travel except to Supreme Council meetings which are usually held over weekends. Expenses incurred for travel, lodging and meals will be paid by the Fraternity.

Each chapter is encouraged to nominate at least one member. This member should be an upperclassman in the Fall, 2011 and have a great deal of leadership experience in his chapter. Experience in student government and other areas of leadership will also be beneficial. The member being nominated must be an undergraduate student through the spring semester of 2012.
