What is a Matching Gift Program?

Many companies include matching gifts as a benefit of their employment. When an employee notifies his company that he has made a charitable donation, the company will make a gift of the same amount, and in some cases more, to the same charitable organization. Matching Gift Programs are a wonderful way for employees to make their charitable dollars stretch farther at no cost to themselves. Simply ask your company's human resources office for a matching gift form and submit it with your donation! Donors who direct a matching gift to the Pike Foundation will receive soft credit that will be included in the tally of his lifetime giving total.

Below is a partial list of companies with matching gift programs that may match your donation to the Pi Kappa Alpha Foundation. Don't see your employer on the list? Be sure to check with your human resources office, personnel department, or community relations office to see if they make matching gifts.

How does a Matching Gift Program Work?

It is extremely easy to process. Gift matching procedures can vary from company to company. The following example is typical.

1. An employee/retiree gets a matching gift form from the employer, usually from the human resource department or company website.
2. After completing the form, the employee/retiree sends it along with the donation to the educational institution or nonprofit charity.
3. The nonprofit certifies on the form that it has received the gift and meets the company's guidelines for receiving a matching gift.
4. The nonprofit returns the form to the company.
5. The company verifies eligibility of the employees/retirees and the nonprofit recipient and sends the check to the nonprofit.
